Shri Shivaji Arts & Commerce College Amravati Grievance Redressal Cell

The Grievance Redressal Cell of Shri Shivaji Arts and Commerce College Amravati was formally constituted with a Co-ordinator, four members and three student representatives to probe into grievances of the students. It redresses the grievances at the College level and grievances of common interest. The Cell maintains a conducive and unprejudiced educational environment. Complaints of students are redressed as soon as they are received. All complaints are scrutinized by the Grievance Redressal Cell and the resolutions are recorded.

Objectives:

The objective of the Grievance Cell is to develop a responsive and accountable attitude among all the stakeholders in order to maintain a harmonious educational atmosphere in the institute. A Grievance Cell is constituted for the redressal of the problems reported by the students of the College with the following objectives:

- Upholding the dignity of the College by ensuring strife free atmosphere in the College through promoting cordial Student-Student relationship and Studentteacher relationship etc.
- Encouraging the Students to express their grievances / problems freely and frankly, without any fear of being victimized.
- Suggestion / Complaint Box is installed in front of the Administrative Block in
 which the Students, who want to remain anonymous, put in writing their
 grievances and their suggestions for improving the Academics / Administration in
 the College.
- Advising Students of the College to respect the right and dignity of one another and show utmost restraint and patience whenever any occasion of rift arises.
- Advising all the Students to refrain from inciting Students against other Students, teachers and College administration.
- Advising all staffs to be affectionate to the Students and not behave in a vindictive manner towards any of them for any reason.

Ragging in any form is strictly prohibited in and outside the institution. Any
violation of ragging and disciplinary rules should be urgently brought to the notice
of the Principal.

Scope:

The cell will deal with Grievances received in writing from the students about any of the following matters:-

- Academic Matters: Related to timely issue of duplicate Mark-sheets, Transfer Certificates, Conduct Certificates or other examination related matters.
- Financial Matters: Related to dues and payments for various items from library, hostels etc.
- Other Matters: Related to certain misgivings about conditions of sanitation, preparation of food, in the canteen, availability of transport, victimization by teachers etc.

Procedure for lodging complaint:

- The students may feel free to put up a grievance in writing/or in the format available in the administrative dept. and drop it in boxes.
- The Grievance Cell will act upon those cases which have been forwarded along with the necessary documents.
- The Grievance Cell will assure that the grievance has been properly solved in a stipulated time limit provided by the cell.

Grievance Handling Mechanism:

- The Grievance Redressal Cell (GRC) shall follow the principles of natural justice while considering the grievances
- Student aggrieved can send their grievance through suggestion boxes which are placed at different location (1Suggestion Box in front of the administrative building and 1 Suggestion Box in the Ladies Hostel) or through Personal Contact to the Grievance Redressal Cell.
- All complaints are collected, analyzed, scrutinized and handled by the College Grievance Redressal Cell.
- After scrutinizing the complaints, general in nature (Teacher, Facilities and Examination)
 complaints are addressed by College Grievance Redressal Cell and other complaints are send
 to respective cell.

- The GRC shall resolve the grievance within period of fifteen days of receiving the complaint
- After receiving the complaint, the concerned parties/persons are called and given equal
 opportunities to put their point of views. This process makes it more transparent and
 unbiased.
- If required GRC will forward grievances to Management on the basis of severity of the issue.

Depending on the seriousness of the problem, the issues are settled by the Cell or by the Principal in consultation with parents and faculty. The collective efforts of the Management, Department heads, Class teachers, various Staff Co-ordinators and the Grievance Redressal Cell resolve the complaints promptly and efficiently. The effective complaint management mechanism improves better stakeholder relationship and contentment. Due to existence of GRC the students, teachers and non teaching staff get a functional platform to share their issues and grievances. The judicious resolution and vigorous engagement of GRC has resulted in creation of faith and belief in the system. This has resulted in the development of vibrant, friendly and conducive environment in the institution.




